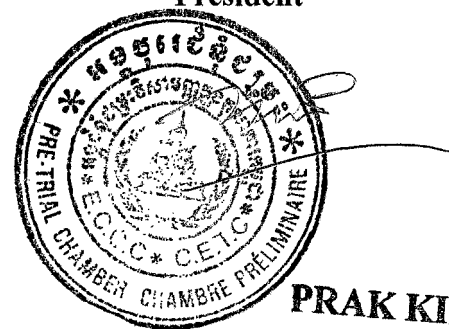

2. The hearing in this case shall be held primarily in public.
3. It is noted that there has been no involvement of the Civil Parties so far in this appeal and that they may be notified of their rights, if any, after the Pre-Trial Chamber’s decision on civil party participation in provisional detention appeals has been rendered.
