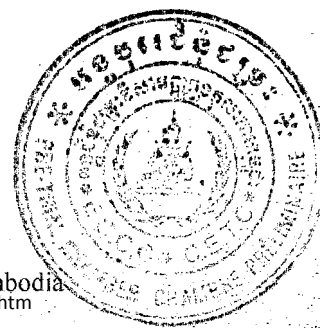

1. **THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) notes the *amicus curiae* briefs received, upon its invitation, from i) the Centre for Human Rights and Legal Pluralism, McGill University, ii) Professor Antonio Cassese and Members of the *Journal of International Criminal Justice* and iii) Prof. Dr. K. Ambos on 27 October 2008 (the “*Amicus Curiae* Briefs”).
2. Pursuant to Rule 33(2), the Parties shall be afforded the opportunity to respond to the *Amicus Curiae* Briefs.
3. The Pre-Trial Chamber notes that the *Amicus Curiae* Briefs were filed only in English but informs the Parties that urgent translation into French and Khmer has been requested and shall respectively be provided on 3 and 7 November 2008.

**THEREFORE, THE PRE-TRIAL CHAMBER HEREBY DIRECTS:**

That any responses by the Parties to the *Amicus Curiae* Briefs should be filed by 17 November 2008, at 4pm.
