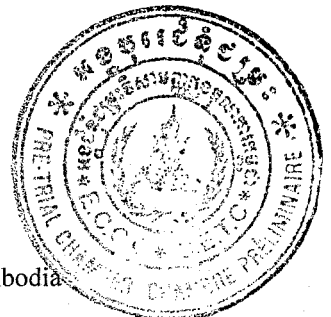

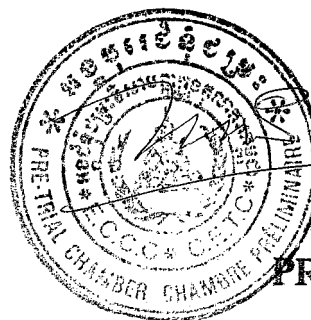
1. **THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) notes its Decision on Khieu Samphan’s Request for a Public Hearing dated 4 November 2008 in which a public hearing on the Appeal against the Decision to Deny the Request for Translation of KHIEU Samphan’s Case File was scheduled for 8 December 2008.
2. The Pre-Trial Chamber has received a request from the Co-Lawyers for the Charged Person to re-schedule the hearing on the basis of the unavailability of the international Co-Lawyer.
