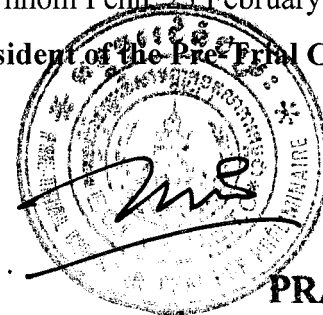
1. By their Request, the Co-Lawyers ask the Pre-Trial Chamber “to:
