BEING SEISED of Case File No. 001/18-07-2007-ECCC/TC pursuant to the "Decision on Appeal Against the Closing Order Indicting Kaing Guek Eav Alias Duch," rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008 ("Decision");

CONSIDERING the Initial Hearing held on 17 and 18 February 2009;

NOTING that 14 to 16 April 2009, 1, 8, and 12 to 15 May 2009, and 18 June 2009 are national holidays;

CONSIDERING that any hearings of the Pre-Trial Chamber will be scheduled on Thursday, 2 and Friday, 3 April 2009, and from Monday, 1 to Friday, 5 June 2009;

MINDFUL of the need to give the parties sufficient notice of the trial schedule;

HEREBY:

ORDER that the Substantive Hearing in the Case N° 001/18-07-2007/ECCC/TC concerning the Accused **KAING Guek Eav** alias **DUCH** will begin on Monday 30 March 2009 at 10:00 hours in the main Courtroom of the ECCC;

ORDER that the Hearing will continue on Tuesday, 31 March and Wednesday, 1 April 2009 at 9:00 hours and thereafter from Monday to Thursday at 9:00 hours every week from Monday, 6 April 2009 until Thursday, 2 July 2009, unless otherwise ordered by the Trial Chamber, and with the exception of the periods indicated below;

ORDER that the Trial Chamber will observe two periods of trial recess from Monday, 13 April 2009 until Friday, 17 April 2009, and from Friday, 1 May 2009 until Friday, 15 May 2009, inclusively. During these periods, the Court Management Section will not accept any documents for filing in Case File No. 001/18-07-2007-ECCC/TC. Time limits for filing documents shall sun during the periods of trial recess. However, if the time limit should expire on a day reliance with Rule 39(4) of the Internal Rules, can be extended to the subsequent working day after the recess.

INDICATE that the Chamber will inform the parties at a later stage of the date of sitting days in the week of 1 to 5 June 2009;

INDICATE that further sitting days will be scheduled at a later stage;

FURTHER INFORM the parties that the order scheduling the calling order of witnesses and Civil Parties will be issued every third week of the month for the following month;

FURTHER ORDER that the present decision shall be notified to the parties and to the Office of the Administration and shall be published on the ECCC's official website.
