THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC");

BEING SEISED of Case File No. 001/18-07-2007-ECCC/TC pursuant to the "Decision on Appeal Against the Closing Order Indicting Kaing Guek Eav Alias Duch," rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;

HAVING RECEIVED the request filed by the Lawyers for the Accused on 9 February 2009 to grant Miss Virginie CHARPENTIER in her capacity as an intern in the legal team of the Defence, the right to meet the Accused in the Detention Centre of the ECCC until 31 May 2009;¹

HAVING RECEIVED the urgent request filed by the Lawyers for the Accused on 23 March 2009 to grant Miss Lucile NATTIEZ in her capacity as a Legal Consultant in the legal team of the Defence, the right to meet the Accused in the Detention Centre of the ECCC until 22 September 2009;²

HAVING RECEIVED the urgent request filed by the Lawyers for the Accused on 30 March 2009 to grant Mme Marie-Paule CANIZARES in her capacity as a Legal Consultant in the legal team of the Defence, the right to meet the Accused in the Detention Centre of the ECCC;³

FINDING that granting members of the Defence team supervised access to the Accused is in the interests of preparing an effective defence;

HEREBY:

GRANTS the aforemetioned requests on the condition that Ms CHARPENTIER, Ms NATTIEZ and Mme CANIZARES be accompanied on any visit to the Accused by at least one other member of the Defence team, which comprises the co-lawyers, legal consultants and the case manager.
