I, **Judge NIL Nonn**, President of the Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

BEING SEISED of Case File No. 001/18-07-2007-ECCC/TC pursuant to the “Decision on Appeal against the Closing Order Indicting Kaing Guek Eav Alias Duch,” rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;

NOTING the “Order Scheduling the Start of the Substantive Hearing and Sitting Days for the First Three Months” dated 23 February 2009;¹

NOTING the “Direction on the Scheduling of the Trial” dated 20 March 2009² and the Order dated 10 April 2009;³

NOTING the “Decision on Protective Measures for Witnesses and Experts and on Parties’ Requests to Hear Witnesses and Experts” dated 3 April 2009;⁴

RECALLING that the Substantive Hearing started on 30 March 2009;

CONSIDERING that the Pre-Trial Chamber has scheduled certain hearings for the first week of June 2009;

MINDFUL OF the need to provide the Parties with sufficient notice of the future scheduling of the trial proceedings, including an indication of when witnesses and experts will be called to testify;

HEREBY:

Orders that the scheduling of the Substantive Hearing for the period of 18 May to 25 June 2009 will be as follows:

- **Implementation of the Communist Party of Kampuchea’s policy at S-21(continued) and Armed Conflict:** from 18 to 21 May 2009. During this period, expert **Craig Etcheson (KW-02)** will be heard on the issue of **Implementation of the**

Communist Party of Kampuchea's policies at S-21. Thereafter, there will be questioning of the Accused on the issue of **Armed Conflict**;

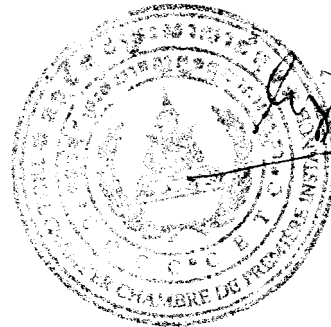
- **Armed Conflict** (continued) and **Functioning of S-21, including Cheung Ek**: from 25 to 28 May 2009 and from 08 to 25 June 2009. During this period, Witnesses KW-09 and KW-08 and expert Nayan Chanda will be heard on the issue of **Armed Conflict**. Thereafter, there will be questioning of the Accused and hearing of Civil Parties D25/1 and D25/3 and of witnesses KW-01 and CP1/6 on the issue of **Functioning of S-21 including Cheung Ek**.

Orders that there will be a trial recess during the first week of June 2009.

Times references are only indicative and the Trial Chamber reserves the right to modify them.

Further orders for the future scheduling of the trial proceedings will be issued in due course.
