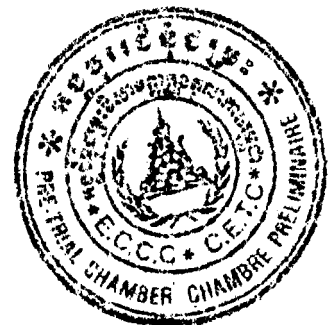

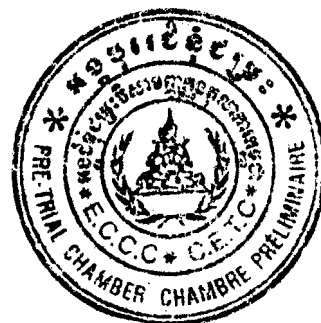

Unrepresented Civil Parties

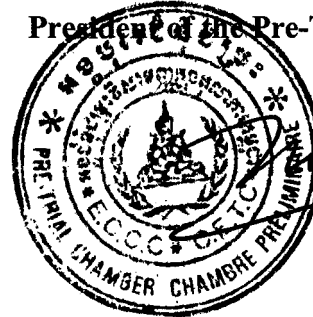
