HEREBY

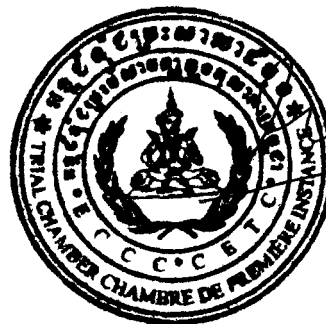
