**PURSUANT** to Internal Rule 98;

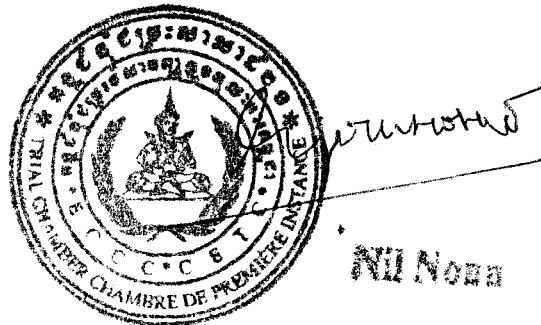
**HEREBY**
