

**THE SUPREME COURT CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia ("ECCC"):

**BEING SEISED** of requests by the Co-Lawyers for the Accused and Civil Parties Groups 1, 2, and 3 to admit additional evidence ("Requests");<sup>1</sup>

**RECALLING** Internal Rule 108(7);

**RECALLING** that, on 22 February 2011, the Supreme Court Chamber, on its own initiative, reminded the Co-Lawyers for the Accused and Civil Parties Group 3 to comply with Internal Rule 108(7) should they wish to admit additional evidence in their respective appeals,<sup>2</sup> and sought confirmation from Co-Lawyers for Civil Parties Group 1 whether or not it intended to file a request to admit additional evidence;<sup>3</sup>

**HAVING** received and reviewed the written response filed by the Co-Prosecutors to the request by the Co-Lawyers for the Accused to admit additional evidence, in which the Co-Prosecutors ask the Chamber to dismiss the Co-Lawyers' request;<sup>4</sup>

CONSIDERING the interests of justice and the circumstances of this case;

**NOTING** that a decision by the Supreme Court Chamber to admit additional evidence is without prejudice to the weight to be accorded to the additional evidence in deciding the appeals;

FOR THE FOREGOING REASONS, the Supreme Court Chamber:

**DECIDES** to grant the Requests and to admit the following additional evidence:
