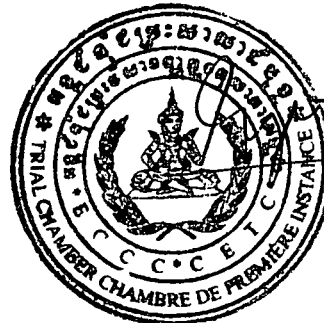
THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

BEING SEISED of Case File No. 002/19-09-2007-ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by Ieng Sary, Ieng Thirith, Nuon Chea and Khieu Samphan,¹ rendered by the Pre-Trial Chamber on 13 January 2011;

NOTING the Co-Prosecutors’ Request for an Extension of Time of 9 May 2011 (E85/1) (“Request”), which seeks a two-day extension of time until 24 May 2011 for the filing of its response to the IENG Sary Motion entitled IENG Sary’s “Motion to Summon King Father NORODOM Sihanouk, Prime Minister HUN Sen, Prince NORODOM Ranariddh and Samdech CHEA Sim” (E85) (“IENG Sary Defence Motion”), due to the impact, including on translation, of three ECCC public holidays which fell during the 10 day response period;

GRANTS the Request and permits the Co-Prosecutors to file a response to the IENG Sary Defence Motion no later than 24 May 2011.
