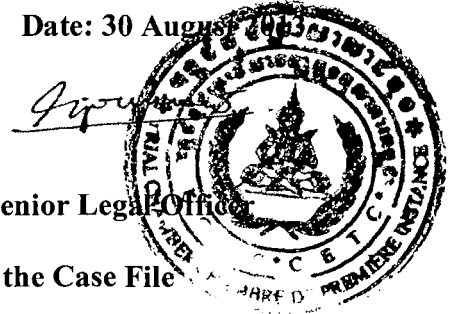

SUBJECT: Reclassification of Additional Documents on the Case File

1. Beginning on 28 November 2011 (E118/4) and on an on-going basis, the Trial Chamber has ordered the re-classification of 'strictly confidential' documents where the justification for that classification no longer exists. On 12 January 2012, the Chamber notified the parties that it would continue to consider whether to reclassify the victim complaints and Civil Party applications on the 'strictly confidential' partition of the case file, as outstanding requests for protective measures were evaluated (E118/5). On 28 June 2013, the Chamber disposed of the final outstanding requests for protective measures (E293).

2. In E293, the Chamber dismissed requests for protective measures related to 28 documents on the 'strictly confidential' partition (*see* D22/1744, D22/3246, D22/1749, D22/2404, D22/2649 and related documents). An additional 81 victim complaints, Civil Party applications and related documents containing personal identification and contact information are classified as 'strictly confidential'. The Supreme Court Chamber has clarified that personal identification and contact information should generally be classified as 'confidential', not 'strictly confidential' (F30/2, para. 7(b)(i)). Further, the Chamber has identified 8 reclassification and correction forms relating to documents already reclassified. The Chamber finds that 'strictly confidential' classification is not justified for these 117 victim complaints, Civil Party applications, correction forms and related documents (*see* Confidential Annex). The Chamber orders that these documents be reclassified from 'strictly confidential' to 'confidential'.

3. The Chamber notes that the vast majority of the remaining documents on the 'strictly confidential' partition of the case file concern the health of an Accused or others. In addition, several documents relate to requests for protective measures concerning individuals who did not ultimately appear before the Chamber and ancillary matters irrelevant to preparation of the parties' cases in Case 002/01. These documents shall remain strictly confidential (E118/4; E118/5; F30/2, para. 7(c)). ~~40~~
