THE SUPREME COURT CHAMBER of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979 ("Supreme Court Chamber" and "ECCC", respectively):

NOTING the judgment of the Trial Chamber in Case 002/01 against NUON Chea and KHIEU Samphân ("Trial Judgment") issued on 7 August 2014;¹

BEING SEIZED of appeals against the Trial Judgment lodged by the Co-Prosecutors, NUON Chea, and KHIEU Samphân (collectively "Appellants");²

RECALLING that the Greffiers of the Supreme Court Chamber notified the Appellants on 19 May 2015 that the Chamber will hold a hearing "of up to four days to hear up to three witnesses [...] in the period between 1 and 10 July (inclusive)", and that "[t]he scheduling order [...] shall follow in due course";³

RECALLING that the Supreme Court Chamber decided to summon witnesses SCW-3, SCW-4 and SCW-5 to give testimony before it;⁴

EMPHASISING, that the purpose of the hearing that is ordered below is primarily to examine the above-mentioned witnesses, and that, therefore, the parties are not requested to make oral submissions concerning the issues raised on appeal, which will be heard during a subsequent hearing, to be scheduled in due course;

NOTING that, although the Civil Parties are not Appellants, "their standing as a party to the proceedings implies the entitlement of all rights generically conferred upon a 'party' by

governing principles and rules",⁵ provided that this does not undermine the principle of equality of arms and the effective management of the proceedings;⁶

HEREBY:

ORDERS that a hearing in Case File No. 002/19-09-2007-ECCC/SC to examine witnesses SCW-3, SCW-4, and SCW-5 be held, scheduled for Thursday, 2 July 2015 at 09:00 a.m. in the main courtroom of the ECCC, and scheduled to continue on Friday, 3 July 2015, Monday, 6 July 2015, and Tuesday, 7 July 2015, as needed;

ATTACHES the tentative timetable for the hearing as Annex to this Order;⁷

INVITES the parties to file their observations, if any, on the timetable by Friday, 5 June 2015.
