# DECISION ON CIVIL PARTY LEAD CO-LAWYERS' REQUEST PURSUANT TO INTERNAL RULE 39(4)(B)

**THE SUPREME COURT CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979 ("Supreme Court Chamber" and "ECCC", respectively);

**RECALLING** that the Supreme Court Chamber has scheduled a hearing for 2, 3, 6 and 7 July 2015, as necessary, to hear the testimonies of SCW-3, SCW-4 and SCW-5;<sup>1</sup>

**RECALLING** that the parties were required to file, no later than Wednesday, 24 June 2015, a list of the documents the parties intend to use during the witnesses' questioning, and to file any objections to any of those documents no later than Friday, 26 June 2015;<sup>2</sup>

**NOTING** that, on 29 June 2015, the Civil Party Lead Co-Lawyers filed their objections to the aforementioned list of documents ("Civil Parties' Objections"), which the Greffiers of the Supreme Court Chamber rejected because they were filed in English only, thereby violating Article 7.1 of the Practice Direction on Filing of Documents before the ECCC;

**NOTING** the "Civil Party Lead Co-Lawyers' Request Pursuant to Internal Rule 39(4)(b)" filed on 30 June 2015 ("Request"),<sup>4</sup> in which Civil Party Lead Co-Lawyers request the Supreme Court Chamber to condone the aforementioned violation and permit them to file the Civil Parties' Objections, in English and Khmer, by 1 July 2015;

**NOTING** that the Request submits that "[c]ompeting urgent obligations relating to the ongoing trial in Case 002/02 and the imminent hearings in Case 002/01 caused an oversight which led to the filing of the [Civil Parties' Objections] in one language on 29 June 2015"; and that granting them leave to file the Civil Parties' Objections in two languages by 1 July would not cause any prejudice to the other parties and would be in the interests of justice; 6

**CONSIDERING** that the Civil Party Lead Co-Lawyers have not advanced convincing reasons as to why the Supreme Court Chamber should retroactively extend the time limit for

the filing of the Civil Parties' Objections pursuant to Internal Rule 39(4)(a) or condone the violation of the regulation concerning linguistic requirements of filings;

**CONSIDERING** that, to the contrary, under the circumstances of the case, where the Supreme Court Chamber needs to issue a decision on the objections raised by the parties in advance of the hearing of the three witnesses scheduled to begin the morning of 2 July 2015, granting the Civil Parties' Request is likely to cause unwarranted delay;

#### **HEREBY**:

**DENIES** the Request.
