HEREBY:

DECIDES that the parties may submit any response to the Request no later than Tuesday, 9 February 2016;

DECIDES that any such response may be filed in English or French in the first instance, with the Khmer translation thereof to follow at the first opportunity;

DECIDES that no reply shall be permitted.
