DECISION ON YIM TITH'S NOTICE OF WITHDRAWAL OF APPEAL AGAINST THE INTERNATIONAL CO-INVESTIGATING JUDGE'S DECISION ON URGENT REQUESTS TO RECONSIDER THE DISCLOSURE OF CASE 004 WITNESS STATEMENTS IN CASE 002/02

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia (the "ECCC") is seised of the "YIM Tith's Notice of Appeal Against the International Co-Investigating Judge's Decision on YIM Tith's Urgent Request for the International Co-Investigating Judge to Reconsider the Disclosure of Case 004 Witness Statements in Case 002/02", filed on 17 August 2015 and registered by the Greffier of the Co-Investigating Judges on 18 August 2015 (the "Notice of Appeal"). <sup>1</sup>

- 1. On 17 August 2015, the Co-Lawyers for YIM Tith filed the Notice of Appeal against a decision issued by International Co-Investigating Judge HARMON (the "Impugned Decision") denying two requests to reconsider the disclosure of Case 004 witness statements in Case 002/02.<sup>3</sup>
- 2. On 4 September 2015, the Legal Officer of the Office of the Co-Investigating Judges informed the Co-Lawyers that International Co-Investigating Judge BOHLANDER considers the Impugned Decision void and that he would re-issue a decision shortly.<sup>4</sup>
- 3. On the same date, the Co-Lawyers filed with the Greffier of the Pre-Trial Chamber a request for guidance regarding the filing of the submissions on appeal.<sup>5</sup>
- 4. On 9 September 2015, the Legal Officer of the Pre-Trial Chamber informed the Co-Lawyers that the Pre-Trial Chamber had granted an extension of time limit to 30 days from re-issuance of a decision by International Co-Investigating Judge BOHLANDER.<sup>6</sup>
- 5. On 30 March 2016, the International Co-Investigating Judge BOHLANDER re-issued the Impugned Decision.<sup>7</sup>

- 6. The Co-Lawyers did not file any submissions on appeal within the time limit prescribed by the Pre-Trial Chamber, which expired on 29 April 2016.
- 7. On 26 May 2016, the Pre-Trial Chamber instructed the Co-Lawyers to file a notice of intent within five days. 8
- 8. On 27 May 2016, the Co-Lawyers filed a notice to withdraw the Appeal<sup>9</sup>.
- 9. The Pre-Trial Chamber recalls that, on the basis of Cambodian and international practice, "a party has the right to withdraw an appeal without seeking leave until the conclusion of the debate between the parties". <sup>10</sup> In the present case, the Co-Lawyers have filed their Notice of Withdrawal before a decision was made under Rule 77(3)(b) of the Internal Rules, hence before the conclusion of the debates on appeal. The Co-Lawyers are therefore allowed to withdraw the Appeal without seeking leave.

#### **DISPOSITION**

### FOR THESE REASONS, THE PRE-TRIAL CHAMBER UNANIMOUSLY HEREBY:

**NOTES** the withdrawal of the Appeal.
