DECISION ON CO-PROSECUTORS' REQUEST FOR EXTENSION OF DEADLINES FOR NOTICES OF APPEAL OF CLOSING ORDERS IN CASE 004/2

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") is seised of the "Co-Prosecutors' Request for Extension of Deadlines for Notices of Appeal of Closing Orders in Case 004/02" filed by the Co-Prosecutors on 23 August 2018 ("Request").¹

1. On 16 August 2018, the National Co-Investigating Judge issued his Closing Order² in Khmer, dismissing the case against AO An, while the International Co-Investigating Judge issued his Closing Order (Indictment)³ in English (collectively "Closing Orders"). Translations of both documents are still pending.

2. On 23 August 2018, the Co-Prosecutors filed the Request, seeking to extend the deadline to file notices of appeals against the Closing Orders. No responses were filed.

3. The Co-Prosecutors seek clarification as to when any notice of appeal of one or both Closing Orders in Case 004/2 will be due, given that two closing orders have been issued for the same case, and argue that they must review both documents in a language they fully comprehend in order to make an informed decision on any appeal.⁴ Moreover, in light of the length of both Closing Orders (each over 400 pages) and their interrelationship, "the Co-Prosecutors require some time to evaluate the Closing Orders and the ramifications of any appeal."⁵ They therefore request that the Pre-Trial Chamber extend the deadline applicable to all parties for any notice of appeal related to either Closing Order to fourteen days after translations of both Closing Orders have been notified.⁶

4. Notices of appeal to the Pre-Trial Chamber must normally be filed within ten days of receiving notification of the order or decision in Khmer and one other official language of the ECCC.⁷ Pursuant to Internal Rules 39(2) and (4), the Pre-Trial Chamber may set and/or

extend any time limits for the filing of documents relating to an appeal. The Pre-Trial Chamber considers that the parties should be able to review both Closing Orders in a language they fully understand before making any decisions regarding any appeals. The Chamber is moreover satisfied that an extension to fourteen days after translations of both Closing Orders have been notified is appropriate.

FOR THESE REASONS, THE PRE-TRIAL CHAMBER UNANIMOUSLY HEREBY:

GRANTS the Request;

ORDERS the parties to file any Notices of Appeal against the Closing Orders in Case 004/2 within fourteen days after translations of both Closing Orders have been notified.
