BEING SEISED OF the Appeals lodged by the National Co-Prosecutor¹ and the Co-Lawyers for AO An,² on 14 December 2018 and 19 December 2018, respectively, against the Closing Order (Indictment) delivered by the International Co-Investigating Judge on 16 August 2018 in Case 004/2,³ and the Appeal lodged by the International Co-Prosecutor on 20 December 2018⁴ against the Order Dismissing the Case against AO An (D359) delivered by the National Co-Investigating Judge on 16 August 2018 in Case 004/2⁵;

CONSIDERING that the briefing on appeal in this case is complete;

NOTING the submissions regarding the hearing, in response to the Pre-Trial Chamber's Notice of 7 May 2019,⁶ filed by the International Co-Prosecutor⁷ on 8 May 2019 and the National Co-Prosecutor⁸ and the Co-Lawyers for AO An⁹ on 9 May 2019;
