



## **DECISION ON ADMISSIBILITY**

Having considered the aforementioned application introduced pursuant to Article VIII(1) of the Human Rights Agreement ("the Agreement") set out in Annex 6 to the General Framework Agreement for Peace in Bosnia and Herzegovina;

Adopts the following decision pursuant to Article VIII(2)(c) of the Agreement and Rules 49(2) and 52 of the Chamber's Rules of Procedure:

**I. INTRODUCTION**

1. The application was introduced on 26 October 2000 and registered on the same day. The applicants requested that the Chamber order a provisional measure to take all necessary action to prevent their eviction. The Chamber rejected this request on 31 October 2000.
2. The applicants complain of their eviction from an apartment which they occupy in Sarajevo

**II. OPINION OF THE CHAMBER**

3. The Chamber notes that the eviction was ordered by the competent court on the ground that the applicants had no legal ground to occupy it. In light of all the material in its possession, the Chamber finds that the present case does not disclose any appearance of a violation of the rights and freedoms guaranteed under the Agreement. It follows that the application must be rejected, in accordance with Article VIII(2)(c) of the Agreement, as manifestly ill-founded.

**III. CONCLUSION**

4. For these reasons, the Chamber, unanimously,

**DECLARES THE APPLICATION INADMISSIBLE.**
