Having considered the aforementioned application introduced pursuant to Article VIII(1) of the Human Rights Agreement ("the Agreement") set out in Annex 6 to the General Framework Agreement for Peace in Bosnia and Herzegovina;

Adopts the following decision pursuant to Article VIII(2)(c) of the Agreement and Rules 49(2) and 52 of the Chamber's Rules of Procedure:

I. INTRODUCTION

1. The application was introduced on 10 January 2001 and registered on the same day. The applicant requested that the Chamber order to the respondent Party, as a provisional measure, to take all necessary action to prevent seizure of fuel stored by the applicant. On 6 April 2001 the Chamber decided not to order the provisional measure requested.

2. The applicant complains of a procedural decision of the Republika Srpska Financial Police, Prijedor Department, dated 17 March 1998, ordering the seizure of the fuel in question.

II. OPINION OF THE CHAMBER

3. In the light of all the material in its possession, the Chamber finds that they do not disclose any appearance of a violation of the rights and freedoms guaranteed under the Agreement. It follows that the application is manifestly ill-founded and must be rejected, in accordance with Article VIII(2)(c) of the Agreement.

III. CONCLUSION

4. For these reasons, the Chamber, unanimously

DECLARES THE APPLICATION INADMISSIBLE.
