

DECISION TO STRIKE OUT

Having considered the aforementioned application introduced pursuant to Article VIII(1) of the Human Rights Agreement ("the Agreement") set out in Annex 6 to the General Framework Agreement for Peace in Bosnia and Herzegovina;

Adopts the following decision pursuant to Article VIII(3)(b) of the Agreement and Rules 49(2) and 52 of the Chamber's Rules of Procedure:

I. INTRODUCTION

- 1. The application was registered on 14 September 2000.
- 2. The applicant complained of his inability to repossess his pre-war apartment, located at Ulica dr. Ante Starčevića no. 60, in Mostar.
- 3. The application was transmitted to the Federation of Bosnia and Herzegovina ("the Federation"). On 15 January 2001 the Federation submitted its observations on admissibility and merits of the application.
- 4. On 10 October 2001 the respondent Party informed the Chamber that the applicant was reinstated into his apartment on 5 December 2000.
- 5. On 22 October 2001 the Chamber sent a letter to the applicant, asking him to confirm that he has been reinstated into possession of his property. On 26 October 2001 the applicant received this letter. The Chamber has not received any answer from the applicant, and the deadline set for his answer has expired on 9 November 2001.

II. OPINION OF THE CHAMBER

- 6. In accordance with Article VIII(3) of the Agreement, "the Chamber may decide at any point in its proceedings to suspend consideration of, reject or strike out, an application on the ground that ... (b) the matter has been resolved; ... provided that such a result is consistent with the objective of respect for human rights."
- 7. Considering that it appears that the applicant has been reinstated into possession of his apartment, and that he has not replied to the letter from the Chamber, the Chamber finds that the matter raised in the application has been resolved. Furthermore, the Chamber finds no special circumstances regarding respect for human rights which require the examination of the application to be continued. The Chamber therefore decides to strike out the application.

III. CONCLUSION

8. For these reasons, the Chamber, unanimously,

STRIKES OUT THE APPLICATION.
