Having considered the aforementioned application introduced pursuant to Article VIII(1) of the Human Rights Agreement ("the Agreement") set out in Annex 6 to the General Framework Agreement for Peace in Bosnia and Herzegovina;

Adopts the following decision pursuant to Article VIII(2)(c) of the Agreement and Rules 49(2) and 52 of the Chamber's Rules of Procedure:

I. INTRODUCTION

1. The application was introduced on 31 January 2003. The applicant requested the Chamber to order the respondent Party, as a provisional measure, to take all necessary actions to prevent his eviction from an apartment which he occupies until the final decision is issued in this case. On 7 February 2003, the Chamber decided not to order provisional measure requested.

2. The applicant complains of a decision of the Service for Administration of Property and Legal Affairs of Centar Sarajevo Municipality of 23 January 2003 ordering his eviction from the apartment which he occupies. The eviction was ordered because the pre-war occupant has obtained a decision of the Commission for Real Property Claims of Displaced Person and Refugees (CRPC) of 8 October 2002 entitling him to regain possession of the apartment and terminating the applicant's right of temporary use of the apartment.

II. OPINION OF THE CHAMBER

3. In accordance with Article VIII(2) of the Agreement, "the Chamber shall decide which applications to accept... In so doing, the Chamber shall take into account the following criteria: ... (c) the Chamber shall also dismiss any application which it considers incompatible with this Agreement, manifestly ill-founded, or an abuse of the right of petition".

4. The Chamber notes that the decision on the applicant's eviction was taken to allow the pre-war occupancy right holder to repossess the apartment. In these circumstances, the Chamber finds that the application does not disclose any appearance of a violation of the rights and freedoms guaranteed under the Agreement. It follows that the application is manifestly ill-founded, within the meaning of Article VIII(2)(c) of the Agreement. The Chamber therefore decides to declare the application inadmissible.

III. CONCLUSION

5. For these reasons, the Chamber, with 6 votes to 1,

DECLARES THE APPLICATION INADMISSIBLE.
