**PRE-TRIAL CHAMBER II** (the "Chamber") of the International Criminal Court (the "Court");

**SITTING** as the full Chamber, pursuant to the Chamber's decision on the 18<sup>th</sup> day of May 2005;

**RECALLING** the warrants of arrest for **JOSEPH KONY**, **VINCENT OTTI**, **OKOT ODHIAMBO**, **RASKA LUKWIYA** and **DOMINIC ONGWEN** issued by the Chamber on the 8<sup>th</sup> day of July 2005 and the amended warrant of arrest for **JOSEPH KONY** issued on the 27<sup>th</sup> day of September 2005 (the "Warrants"); the requests for arrest and surrender issued on the 8<sup>th</sup> day of July 2005 addressed to the Republic of Uganda, the amended request for arrest and surrender of **JOSEPH KONY** issued on the 27<sup>th</sup> day of September 2005 addressed to the Republic of Uganda and the request for arrest and surrender of **JOSEPH KONY** issued on the 27<sup>th</sup> day of September 2005 addressed to the Republic of Uganda and the requests for arrest and surrender issued on the 27<sup>th</sup> day of September 2005 addressed to the Democratic Republic of the Congo and the Republic of Sudan (collectively, the "Requests for arrest and surrender");

**NOTING** the Chamber's "Decision on the Prosecutor's urgent application dated 26 September 2005", deciding to hold a status conference on the 3<sup>rd</sup> day of October 2005 at 3:00 p.m. by way of a hearing in closed session (the "Status Conference");

**NOTING** that the purpose of the Status Conference is for the Chamber to be informed, *inter alia*, of the status of the transmission of the Requests for arrest and surrender to the relevant States and of the execution of the Warrants;

**NOTING** that, pursuant to the Chamber's decisions dated the 8<sup>th</sup> day of July 2005 and the 27<sup>th</sup> day of September 2005, the Registrar is the organ of the Court to transmit the Requests for arrest and surrender and the Warrants;

**CONSIDERING**, therefore, the attendance of the Registrar to the Status Conference to be necessary for the Chamber to be properly informed on matters relating to the transmission of the Requests for arrest and surrender;

FOR THESE REASONS;

#### THE CHAMBER HEREBY:

**ORDERS** the Registrar or a designated representative to attend the Status Conference scheduled for the 3<sup>rd</sup> day of October 2005 at 3:00 p.m.;

**DECIDES** that this Order be kept under seal until further order by the Chamber.
