NOTING the "Decision Concerning Pre-Trial Chamber I's Decision of 10 February 2006 and the Incorporation of Documents into the Record of the Case against Mr Thomas Lubanga Dyilo" (the "Decision"), in which Pre-Trial Chamber I (the "Chamber") requested "the Registrar to remove the decisions with the quotes: ICC-01/04-01/06-1-US-Exp-Corr and ICC-01-04-01/06-7-US-Exp from the record of the case against Mr Thomas Lubanga Dyilo and to incorporate them into the record of the

NOTING that, pursuant to the Decision, the Registrar incorporated into the record of the situation in the Democratic Republic of the Congo (the "DRC") and removed from the record of the case against Mr Thomas Lubanga Dyilo the following three documents: ICC-01/04-01/06-1-US-Exp, ICC-01/04-01/06-1-US-Exp-Corr and ICC-01-04-01/06-7- US-Exp; and that the said documents are currently part of the record of the situation in the DRC, with the reference numbers ICC-01/04-118-US-Exp, ICC-01/04-118-US-Exp-Corr and ICC-01/04-119-US-Exp, and are classified under seal and "ex parte, Prosecution only";

NOTING the decision of the Chamber of 14 March 2006 designating Judge Sylvia Steiner as single judge of the Chamber from 15 until 22 March 2006 at 12.00 hours in the case of the Prosecutor v. Thomas Lubanga Dyilo;²

NOTING articles 57 (3) (c), 67 (1) and 68 (1) of the Rome Statute (the "Statute") and rules 87 (2) (c) and 88 (4) of the Rules of Procedure and Evidence (the "Rules");

CONSIDERING that, apart from the three above-mentioned documents, unreducted versions of all documents related to the Prosecution's Application against Mr Thomas Lubanga Dyilo are currently part of the record of the case against Mr Thomas Lubanga Dyilo;

CONSIDERING that for the sake of completeness of the record against Mr Thomas Lubanga Dyilo, the three said documents, in addition to remaining part of the record of the situation in the DRC, must be included in the record of the case against Mr Thomas Lubanga Dyilo;

FOR THESE REASONS

ORDER the Registrar to:

- (a) re-incorporate into the record of the case against Mr Thomas Lubanga Dyilo the following documents:
 - a. ICC-01/04-118-US-Exp (former ICC-01/04-01/06-1-US-Exp);
 - b. ICC-01/04-118-US-Exp-Corr (former ICC-01/04-01/06-1-US-Exp-Corr); and
 - c. ICC-01/04-119-US-Exp (former ICC-01-04-01/06-US-7-Exp).

(b) classify the said documents in the record of the case against Mr Thomas Lubanga Dyilo under seal and "ex parte, Prosecution only" until otherwise ordered by the Chamber.
