**PRE-TRIAL CHAMBER II** ("the Chamber") of the International Criminal Court ("the Court");

**NOTING** article 39(2)(b)(iii) of the *Rome Statute* ("the Statute"), pursuant to which the functions of the Pre-Trial Chamber shall be carried out either by three judges of the Pre-Trial Division or by a single judge of that division in accordance with the Statute and the *Rules of Procedure and Evidence* ("the Rules");

**NOTING** article 57(2)(b) of the Statute, pursuant to which, in all cases other than those governed by article 57(2)(a), a single judge of the Pre-Trial Chamber may exercise the functions provided for in the Statute, unless otherwise provided for in the *Rules of Procedure and Evidence* or by a majority of the Pre-Trial Chamber;

**NOTING** rule 7(1) of the Rules, pursuant to which the Pre-Trial Chamber shall designate a judge as a single judge on the basis of objective pre-established criteria;

**NOTING** regulation 47(1) of the *Regulations of the Court*, pursuant to which the designation of a single judge shall be based on criteria agreed upon by the Pre-Trial Chamber, including seniority of age and criminal trial experience, the issues involved and the distribution of work within the Chamber as well as the proper management and efficiency in the handling of cases;

**NOTING** the Chamber's previous decisions on the unsealing of documents in the records of the situation and of the case, dated 13 October 2005,<sup>1</sup> 2 November 2005<sup>2</sup> and 9 March 2006;<sup>3</sup>

**NOTING** the order dated 18 April 2006, by which the Chamber requested the Prosecutor to submit an updated proposal detailing the suggested treatment of all relevant documents in the record both of the situation and of the case;<sup>4</sup>

**NOTING** the "Prosecutor's Submission of Information on Further Unsealing of Documents of the Record" dated 2 May 2006,<sup>5</sup> by which the Prosecutor filed an updated document detailing his proposed treatment of all documents of the record of the situation and of the case;

**CONSIDERING** that at this stage of the proceedings in the situation in Uganda and in the case of *The Prosecutor v. Joseph KONY, Vincent OTTI, Raska LUKWIYA, Okot ODHIAMBO* and *Dominic ONGWEN*, the designation of a single judge for unsealing of documents will enable the matter to be handled efficiently;

## FOR THESE REASONS,

**DECIDES** to designate Judge Fatoumata Dembele Diarra as Single Judge, responsible for the unsealing of documents in the situation in Uganda and the case concerning **Joseph KONY**, **Vincent OTTI**, **Raska LUKWIYA**, **Okot ODHIAMBO** and **Dominic ONGWEN**.
