I, Judge Sylvia Steiner, judge at the International Criminal Court (the "Court");

**NOTING** the "Décision sur les demandes de participation à la procédure a/0001/06, a/0002/06 et a/0003/06 dans le cadre de l'affaire *Le Procureur c. Thomas Lubanga Dyilo* et de l'enquête en République démocratique du Congo" issued by Pre-Trial Chamber I ("the Chamber") on 28 July 2006, whereby the Chamber grants the status of victims to applicants a/0001/06 to a/0003/06 in the case against Thomas Lubanga Dyilo;

**NOTING** articles 67, 68 and 82 (1) (d) of the Statute, rule 89 of the Rules of Procedure and Evidence and regulations 24 and 34 of the Regulations of the Court ("the Regulations");

**CONSIDERING** that according to the chapeau of regulation 34 of the Regulations, a time limit other than the 21 days provided for in paragraph (b) of this regulation may be fixed by the single judge;

**CONSIDERING** the current stage of the proceedings and that the issues raised by the Defence are on the status of victims and their participation in the case against Thomas Lubanga Dyilo;

## FOR THESE REASONS

**DECIDE** to give the Prosecution and the Legal Representatives of the Victims until Friday 18 August 2006 at 16.00 hours to file their responses to the Request.
