I, Judge Sylvia Steiner, judge at the International Criminal Court ("the Court");

NOTING the "First Decision on the Prosecution Requests and Amended Requests for Redactions under Rule 81" ("the Decision), issued by the single judge on 15 September 2006;

NOTING the "Provision of Summary Evidence to the Pre-Trial Chamber" ("the Prosecution First Application"),² filed by the Prosecution on 26 September 2006, in which the Prosecution requests the authorisation of the Chamber to disclose to the Defence proposed summary evidence of some witness statements and transcripts of witness interviews;

NOTING the "Provision of Summary Evidence to the Pre-Trial Chamber" ("the Prosecution Second Application"),³ filed by the Prosecution on 29 September 2006, in which the Prosecution requests the authorisation of the Chamber to disclose proposed summary evidence of some additional statements and transcripts of witness interviews;

NOTING articles 57 (3) (c), 61 (3) (b), 67 (2), 68 (1) and 69 (4) of the Rome Statute ("the Statute") and rules 76 to 83 of the Rules of Procedure and Evidence ("the Rules");

CONSIDERING the need to deal with the Prosecution First Application and the Prosecution Second Application in an *ex parte* hearing with the Prosecution and the representatives of the Victims and Witnesses Unit;
