**PRE-TRIAL CHAMBER I** (“the Chamber”) of the International Criminal Court (the “Court”);

**NOTING** the “Decision Designating a Single Judge in the Case of the Prosecutor v. Thomas Lubanga Dyilo”<sup>1</sup> issued by the Chamber on 22 march 2006, whereby the Chamber decides to designate Judge Sylvia Steiner as single judge of the Chamber in the case against Thomas Lubanga Dyilo in the situation in the Democratic Republic of the Congo (“the DRC”), responsible, under article 57 (2) of the Rome Statute (the “Statute”), for exercising the functions of the Chamber in that case, including those functions provided for in rule 121 (2) (b) of the Rules of Procedure and Evidence (the “Rules”);

**NOTING** articles 39 (2) (b) (iii) and 57 (2), 61 of the Statute, rules 7 (1), 121 and 122 of the Rules and regulation 47 of the Regulations of the Court;

**CONSIDERING** that pursuant to Rule 122 (1) of the Rules, it is the function of the Presiding Judge of the Chamber to determine how the confirmation hearing shall be conducted;

**FOR THESE REASONS,**

**DECIDES** to designate Judge Claude Jorda as single judge for the case against Thomas Lubanga Dyilo in the situation of the DRC, responsible, under article 57 (2) of the Statute, for exercising the functions of the Chamber in that case, and in

particular those relating to Rule 122 (1) of the Rules, from Friday 6 October 2006 until the end of the confirmation hearing.


