I, Judge Claude Jorda, judge at the International Criminal Court ("the Court");

**NOTING** the "Request for further information regarding the confirmation hearing and for the appropriate relief to safeguard the rights of the Defence and Thomas Lubanga Dyilo" ("the Defence First Request") filed by the Defence on 20 September 2006 in which the Defence requests the Chamber to *inter alia* i) order the Prosecution to file any legal submissions it intends to make in written form, as soon as possible; ii) grant the Defence the right to file legal and factual submissions in written form after the confirmation hearing;<sup>1</sup>

**NOTING** the "Decision establishing a Deadline in Relation to the Defence Request for the Interim Release of Thomas Lubanga Dyilo" issued by the single Judge on 22 September 2006 whereby the single Judge gives the Prosecution and the Legal Representatives of Victims a/0001/06 to a/0003/06 until 9 October 2006 to file a response to the Defence request for interim release of Thomas Lubanga Dyilo;<sup>2</sup>

**NOTING** the "Prosecution's Response to the Defence Request for Interim Release" filed on 9 October 2006("the Prosecution First Response");<sup>3</sup>

**NOTING** the "Defence's Request for an Order of the Pre-Trial Chamber to the Prosecution to provide legal argument to the Defence in advance of the confirmation

hearing and for a variation of the time limit" ("the Defence Second Request")<sup>4</sup> filed on 16 October 2006 in which it reiterates its First Request that the Chamber order the Prosecution to provide the following information to the Defence at least twenty days

1) A copy of the skeleton legal argument that will be used by the Prosecution

2) A list of any cases, laws, conventions, books or articles cited by the

Prosecution

before the confirmation hearing:

3) Copies of any cases, laws, conventions, books or articles cited by the

Prosecution (including the section referred to and the entire decision or case to

verify the context in which it is used);

NOTING the Prosecution's Response to the Defence Second Request ("the

Prosecution Second Response")5;

NOTING the decision on the date of the confirmation hearing6 filed on the 5 October

2006 in which the Chamber decides that "pursuant to rule 122(1) a hearing will be

held on 26 October at 10.00am to determine how the confirmation hearing is to be

conducted";

**NOTING** articles 61, of the Rome Statute of the International Criminal Court ("the statute") and rule 121 and 122 (1) of the Rules of Evidence and Procedure ("the Rules");

**CONSIDERING** that the two Requests for legal argument by the Defence are not recognized by any of the laws of the ICC;

CONSIDERING that the hearing of 26 October 2006 to determine how the confirmation hearing is to be conducted is the appropriate forum to discuss the Defence request to file legal and factual submissions in written form after the confirmation hearing;

## FOR THESE REASONS,

**DECIDES** to reject the Defence request for an order of the Chamber to the Prosecution to provide legal argument to the Defence in advance of the confirmation hearing;
