**NOTING** the "Prosecution's Application for warrants of arrest under Article 58 and Request for Expedited Consideration", filed in two parts on 22 and 25 June 2007, ("the Prosecution Application");<sup>2</sup>

**NOTING** articles 57(3)(c) and 68 (1) of the Rome Statute ("the Statute") and rule 87 (2)(c) of the Rules of Procedure and Evidence ("the Rules"),

**CONSIDERING** that the Prosecution has requested that the Prosecution Application be considered in an urgent basis, particularly concerning Germain Katanga; and that the current form of the Prosecution Application needs to be formatted;

**CONSIDERING** also that there is a need to convene an ex parte hearing, in closed session, to address issues pertaining to the protection of witnesses and victims;

**DECIDES** that the Prosecution shall file by 9 July 2007 a formatted version of the Prosecution Application in which all information that could identify individuals for
