Catherine Mabille as Defence Counsel for Mr. Thomas Lubanga Dyilo.

On 12 July 2007 the judges of Trial Chamber I elected a Presiding Judge in the case

against Mr. Thomas Lubanga Dyilo pursuant to Regulation 13(2) of the Regulations

of the Court and HEREBY DECLARE that Judge Adrian Fulford is Presiding Judge

in the case against Mr. Thomas Lubanga Dyilo.
