PRE-TRIAL CHAMBER II of the International Criminal Court (the "Court");

NOTING article 39, paragraph 2(b)(iii) of the Rome Statute (the "Statute"), pursuant

to which the functions of the Pre-Trial Chamber shall be carried out either by three

judges of the Pre-Trial Division or by a single judge of that division in accordance

with the Statute and the Rules of Procedure and Evidence (the "Rules");

NOTING article 57, paragraph 2(b) of the Statute according to which a single judge

of the Pre-Trial Chamber may exercise the functions provided for in the Statute other

than those listed under article 57, paragraph 2(a), unless otherwise provided for in

the Rules or by a majority of the Pre-Trial Chamber;

NOTING rule 7, sub-rule 2 of the Rules pursuant to which the designated single

judge shall make the appropriate decisions on those questions on which decision by

the full Chamber is not expressly provided for in the Statute or the Rules;

NOTING the "Decision Designating a Single Judge on Victims' Issues" of the Pre-Trial

Chamber II, issued on 22 November 2006 ("the 22 November 2006 Decision"),

designating Judge Mauro Politi as single judge responsible for all issues arising in

connection with victims' applications for participation in the proceedings in the

situation in Uganda and in the case against Joseph Kony, Vincent Otti, Raska

Lukwiya, Okot Odhiambo and Dominic Ongwen;

NOTING regulation 47, sub-regulation 1, of the Regulations of the Court (the

"Regulations"), providing that the designation of a single judge shall be based upon

criteria agreed upon by the Pre-Trial Chamber, including considerations of the issues

involved, the circumstances of the proceedings before the Chamber, the distribution

CONSIDERING that at this stage of the proceedings in the situation in Uganda and

in the case against Joseph Kony, Vincent Otti, Okot Odhiambo and Dominic

Ongwen, the replacement for the period of 6 September to 15 October 2007 of the

single judge appointed by the 22 November 2006 Decision will ensure the proper

management and efficiency in the handling of the victims' issues;

HAVING REGARD THERETO AND FOR THESE REASONS, THE CHAMBER

HEREBY:

DECIDES to designate Judge Ekaterina Trendafilova as single judge responsible for

all victims' issues in the proceedings in the situation in Uganda and in the case

against Joseph Kony, Vincent Otti, Okot Odhiambo and Dominic Ongwen for the

period of 6 September to 15 October 2007.

DECIDES that, as from 16 October 2007, Judge Mauro Politi will resume his

functions as single judge responsible for all victims' issues in the situation in Uganda

and in the case against Joseph Kony, Vincent Otti, Okot Odhiambo and Dominic

Ongwen, in accordance with the 22 November 2006 Decision.
