**I, Judge Akua Kuenyehia**, judge at the International Criminal Court (“the Court”);

**NOTING** the “Warrant of Arrest against Germain Katanga” issued on 2 July 2007 by Pre-Trial Chamber I (“the Chamber”);<sup>1</sup>

**NOTING** the “Decision to unseal the warrant of arrest against Germain Katanga and related document”<sup>2</sup> issued by the Single Judge on 18 October 2007;

**NOTING** the information provided by the Registrar confirming the arrest of Germain Katanga, his surrender to the officials of the Court and his transfer to the Court’s Detention Center in The Hague;

**NOTING** article 60(1) and 67 of the Rome Statute (“the Statute”), rule 121(1) of the Rules of Procedure and Evidence (“the Rules”) and regulations 20 and 21 of the Regulations of the Court (“the Regulations”);

**CONSIDERING** that according to rule 121(1) of the Rules, Germain Katanga shall appear before the Pre-Trial Chamber promptly upon arriving at the Court;

**CONSIDERING** that the publicity of hearings may extend beyond the courtroom pursuant to regulation 21 of the Regulations;


