**DECISION ON THE INCORPORATION OF DOCUMENTS IN THE RECORD OF  
THE CASE AND CONVENING A HEARING**

**I, Judge Akua Kuenyehia**, judge at the International Criminal Court (the “Court”);

**NOTING** the Prosecution’s application for a warrant of arrest against Germain Katanga under article 58 of the Statute, part one and two (“the Prosecution Application”),<sup>1</sup> filed by the Prosecution on 22 and 25 June 2007;

**NOTING** the warrant of arrest against Germain Katanga<sup>2</sup> (“the Warrant of Arrest”) issued by the Chamber on 2 July 2007;

**NOTING** the “Order on the execution of the warrant of arrest for Germain Katanga”<sup>3</sup> (“the Order”) issued by the Chamber on 2 July 2007;

**NOTING** the “Decision on the evidence and information provided by the Prosecution for the issuance of a warrant of arrest for Germain Katanga”<sup>4</sup> (“the Decision”) issued on 6 July 2007 whereby the Chamber set out the analysis of the evidence and information provided by the Prosecution in connection with its application for a warrant of arrest against Germain Katanga;

**NOTING** the “Prosecution’s Amended Application Pursuant to Rule 81(2) and Rule 81(4)”<sup>5</sup> filed on 10 September 2007 in which the Prosecution proposes redactions to witness statements 7, 13 and 14;

**NOTING** articles 57 (3) (c), 67 (1) and 68 (1) of the Rome Statute (“the Statute”), rules 87 (2) (c) and 88 (4) of the Rules of Procedure and Evidence (“the Rules”) and regulation 8 (c) of the Regulations of the Court;

**CONSIDERING** that the Germain Katanga is already in the Detention Center of the Court and that the warrant of arrest against him has already been unsealed and made public;

**CONSIDERING** that the Prosecution has filed the proposed formatted version of the Prosecution Application showing the track changes and a revised version of the redacted formatted version of the Prosecution Application;

**FOR THESE REASONS**

**DECIDE** to incorporate in the record of the case a copy of the following documents which are part of the record of the Situation in the Democratic Republic of the Congo:



- 2) Redactions concerning the statements of witnesses 7, 13 and 14 of the Prosecution Application in light of the fact that REDACTED;
- 3) Matters concerning the unsealing and reclassification of documents contained in the record of the case
