1. On 21 November 2007, the Office of Public Counsel for Victims filed the "OPCV's request to submit observations or otherwise be heard on point E of the Order of 14 November 2007 and on the issue of the dual status of witnesses/victims".¹
2. The Trial Chamber will allow the Office of Public Counsel for Victims to present oral observations on point E of the Order of 14 November on protective measures for victim applicants at the hearing on 4 December 2007,² subject to objections of the parties and participants.
3. The Chamber notes that submissions by the parties and participants on the issue of the dual status of witnesses/victims were heard at the hearing on 29-30 October 2007 at the request of the presiding Judge.³ The Office of Public Counsel for Victims was allowed to file written observations on the victims issues dealt with at the hearing on 9 November as it was not in a position to make submissions at the hearing.⁴ Although the Office of Public Counsel for Victims' observations⁵ covered the issues of witness proofing and expert witnesses which the Office of Public Counsel for Victims was not specifically invited to comment upon, it did not deal with the issue of the dual status of witnesses/victims discussed at the hearing. Notwithstanding that history, the Chamber will allow the Office of Public Counsel for Victims to make oral submissions at the hearing (subject to objections of the parties and participants) but only if the issue remains extant.
4. The Chamber orders that objections, if any, to the Office of Public Counsel for Victims's participation at the hearing on the two issues set out shall be filed in



writing by 30 November 2007.

5. The Trial Chamber has adopted this approach on an exceptional basis, considering the short time available before the hearing, and because, at this stage of the case, the Chamber may be assisted by the views of the Office of Public Counsel for Victims on these issues of principle. However, the request generally raises the issue of the role of the Office of Public Counsel for Victims in its capacity as legal representative of victim applicants and as an independent body established to "provide support and assistance to the legal representatives for victims and to victims".⁶ The Chamber may list this issue for submissions from the parties and participants in due course.
6. The Chamber hereby partially grants the Office of Public Counsel for Victims' request, as set out above.
