



The Trial Chamber heard oral submissions on two applications of the Office of the Prosecutor ("prosecution") for the lifting of redactions and for the non disclosure of information,<sup>1</sup> as well as on an urgent "Prosecution's application for extension of time-limit for disclosure"<sup>2</sup> at a public hearing on 11 December 2007.<sup>3</sup> The Chamber subsequently also heard the prosecution on its applications for specific redactions *ex parte* on the same day.<sup>4</sup>
2. As the deadline for the disclosure of the prosecution's evidence is 14 December 2007,<sup>5</sup> the Chamber hereby schedules a hearing to deliver an oral decision on the prosecution's applications on Thursday 13 December 2007 at 10.00 with all the parties and participants.
