**I, Judge Sylvia Steiner**, judge at the International Criminal Court (the “Court”);

**NOTING** the “Decision Establishing Time Limits for Decisions on Protective Measures and Requests for Redactions”,<sup>1</sup> issued by the Single Judge on 12 December 2007;

**NOTING** the *ex parte*, closed session hearing with the Prosecution and the VWU held on 14 December 2007;<sup>2</sup>

**NOTING** the “First Decision on the Prosecution Request for Authorisation to Redact Witness Statements”<sup>3</sup> (“the First Decision on Redactions”), issued by the Single Judge on 14 December 2007, by which the Single Judge partially granted the Prosecution’s request for authorisation to redact information in the interview notes and statements of witnesses 1, 3, 7, 8, 12, 13 and 14;

**NOTING** the “Decision on the Prosecution Request for Authorisation to Redact Statements of Witnesses 4 and 9”<sup>4</sup> (“the Second Decision on Redactions”) issued by the Single Judge on 21 December 2007, by which the Single Judge partially granted the Prosecution’s request for authorisation to redact information in the interview notes and statements of witnesses 4 and 9;

**NOTING** the “Prosecution's Application Pursuant to Rule 81(2) and Rule 81(4) for Redactions to Statements of Witnesses and Related Materials to Be Relied Upon at the Confirmation Hearing”<sup>5</sup> filed by the Prosecution on 15 January 2008;

**NOTING** the “Corrigendum to Prosecution's Application Pursuant to Rule 81(2) and Rule 81(4) for Redactions to Statements of Witnesses and Related Materials to Be Relied Upon at the Confirmation Hearing dated 14 January 2008 and Submission of Additional Materials”<sup>6</sup> filed by the Prosecution on 16 January 2008;

**NOTING** the “Second Corrigendum to Prosecution's Application Pursuant to Rule 81(2) and Rule 81(4) for Redactions to Statements of Witnesses and Related Materials to Be Relied Upon at the Confirmation Hearing Dated 14 January 2008 and Submission of Additional Materials”<sup>7</sup> filed by the Prosecution on 22 January 2008;

**NOTING** articles 57(3) (c) and 68 of the Rome Statute (“the Statute”), rules 76 to 83, and 121 of the Rules of Procedure and Evidence (“the Rules”);

**CONSIDERING** that issues relating to witnesses 7, 8, 9 and 12 which arose from the requests for redactions and the 14 December 2007 hearing, necessitate the Single Judge to convene another hearing;

**CONSIDERING** that the issues relating to witnesses 7, 8, 9 and 12 shall be heard in an *ex parte* hearing and in closed session with the Prosecution; and that, in order to facilitate the hearing, the pending questions relating to the above mentioned


