**NOTING** the "Prosecution's Application Pursuant to Rule 81(2) and Rule 81(4) to

Statement of Witness 2"1 ("the Prosecution's Application") and its confidential ex

parte annexes, filed by the Prosecution on 27 November 2007, in which the

Prosecution requested, inter alia, the authorisation of the Single Judge to redact

certain parts of the statement of Witness 2 ("Witness 268");

**NOTING** the "Prosecution's Application Pursuant to Rule 81(2) and Rule 81(4) for

Redactions to Statements of Witnesses and Related Materials to Be Relied Upon at

the Confirmation Hearing" filed by the Prosecution on 15 January 2008, in which

the Prosecution requested, inter alia, the authorisation of the Single Judge to redact

certain parts of a document related to Witness 268;

**NOTING** the "Amended Submission of Prosecution's Application Pursuant to Rules

81(1) 81(2) and 81(4) for Redactions to Screening Notes and Transcripts of Witnesses

2, 5, 6, 10, 0163, 0238, 0287, 0233,0267, 0271 and 0132" ("the Amended Prosecution's

Application") and its confidential ex parte annexes filed by the Prosecution on 27

February 2008;<sup>3</sup>

**NOTING** articles 57(3) (c), 61(3) and 68 of the *Rome Statute* ("the Statute"), rules 15,

76 to 83, and 121 of the Rules of Procedure and Evidence ("the Rules") and regulation

28(1) of the *Regulations of the Court* ("the Regulations");

**CONSIDERING** that, in light of the decisions on redactions issued by the Single

Judge since the Prosecution's Application, there is a need for the Prosecution to

review the requested redactions in the Prosecution's Application; that the Single

Judge has also found some inconsistencies in the Prosecution's Application in

relation to the statement of Witness 268; and that in Annex I to the present decision,

which is issued *ex parte* and available only to the Prosecution, the Single Judge has

pointed out some of the aforementioned inconsistencies;

CONSIDERING therefore that, to enable the Single Judge to decide upon the

requested redactions in the Prosecution's Application and in the Amended

Prosecution's Application, the Prosecution shall clarify and review its requests for

redactions in relation of Witness 268's statement and document, pursuant to rule 81

(2) and (4) of the Rules, in light of, but not limited to, Annex I to the present decision;

**CONSIDERING** further that, for the abovementioned reasons, the Prosecution shall,

after the review of its requests for redactions, resubmit the Annex A and Annex A1

to the Prosecution's Application and the Amended Prosecution's Application;

FOR THESE REASONS

**ORDER** the Prosecution to clarify and review its requests for redactions in the

Annex A and Annex A 1 of the Prosecution's Application, and to resubmit such

Annexes by Monday 14 April 2008 at 16h00;
