PRE-TRIAL CHAMBER I of the International Criminal Court (“the Chamber” and “the Court”, respectively);

NOTING the arrest and surrender of Mathieu Ngudjolo Chui to the Court and his transfer to the Detention Centre at the seat of the Court in The Hague on the 7 February 2008;¹

NOTING the status conferences held on the 3 June 2008² and 19 June 2008,³ and the respective submissions of the Defence for Mathieu Ngudjolo Chui⁴ and the Registrar on family visits;⁵

NOTING the oral ruling of the Single Judge, ordering the Registrar to provide a report on the measures undertaken to facilitate that passports or any alternative documents are issued for the family members of Mathieu Ngudjolo Chui;⁶

NOTING the “*Rapport du Greffe sur l’état d’avancement des demandes de passeports pour les familles des personnes détenues pour les besoins des visites familiales*”⁷ filed by the Registrar on 23 June 2008;

NOTING the confirmation hearing in the case of *The Prosecutor v. Germain Katanga and Mathieu Ngudjolo Chui* which took place from the 27 June 2008 to 16 July 2008;

NOTING the “*Requête de la Défense en vue de solliciter de la Chambre Préliminaire d’obtenir de la République Démocratique du Congo sa diligente coopération en vue de la délivrance immédiate aux membres de la famille (épouse et enfants) de Monsieur Mathieu Ngudjolo des passeports et ou de tout autre document de voyage officiel leur permettant de faire le déplacement de La Haye (Pays-Bas) pour rendre visite à leur mari et père*” (“the Defence Request”)⁸ filed by the Defence for Mathieu Ngudjolo Chui on the 10 September 2008;

NOTING article 57 of the *Rome Statute*, rule 13(1) of the *Rules of Procedure and Evidence*, regulations 24bis and 100 of the *Regulations of the Court* and regulation 179(1) of the *Regulations of the Registry*;

CONSIDERING that the Defence for Mathieu Ngudjolo Chui requests the Chamber to:

- (i) invite the Democratic Republic of the Congo (“the DRC”) to provide the family members of Mathieu Ngudjolo Chui with (a) their passports; and (b) all other documents necessary for the issuance of their visas by The Netherlands in order to facilitate their entry into The Netherlands and their visit to Mathieu Ngudjolo Chui;
- (ii) order the Registrar to transmit the above-indicated invitation to the President and the Minister of Foreign Affairs of the DRC, the person responsible for delivering passports; and
- (iii) declare that in case the specified documents are not issued, the Chamber will refer this case of non-cooperation by the DRC to the Assembly of States Parties;⁹

CONSIDERING that the Chamber finds that a second report from the Registrar on (i) the status of measures taken by the Registrar to facilitate the issuance of passports for Mathieu Ngudjolo Chui's family members and (ii) any developments reported to the Registrar in respect of the issuance of passports and other necessary documentation by the DRC, is necessary;

CONSIDERING that taking into account the last Report of the Registry as well as the previous requests and complaints made by the Defence for Germain Katanga,¹⁰ the Chamber would benefit from receiving an updated report from the Registry also in relation to family visits and issuance of passports for family members of Germain Katanga;


FOR THESE REASONS
