**THE PRESIDENCY** of the International Criminal Court;

**NOTING** its decision of 14 March 2006 constituting Pre-Trial Chambers, whereby Pre-Trial Chamber II was composed of Judges Mauro Politi, Fatoumata Dembele Diarra and Ekaterina Trendafilova;<sup>1</sup>

**NOTING** its decision of 22 April 2008, pursuant to which Pre-Trial Chamber III was composed of Judges Hans-Peter Kaul, Fatoumata Dembele Diarra and Ekaterina Trendafilova;<sup>2</sup>

**NOTING** the decision of the Presidency of 24 October 2008 (i) temporarily attaching Judges Fatoumata Dembele Diarra and Fumiko Saiga to the Trial Division; and (ii) constituting Trial Chamber II, composed of Judges Fatoumata Dembele Diarra, Fumiko Saiga, and Bruno Cotte;<sup>3</sup>

**NOTING** article 39 of the Statute and regulation 46 of the Regulations of the Court;

**HEREBY DECIDES** that henceforth:

- (i) Judge Fatoumata Dembele Diarra shall be replaced by:
  - a. Judge Hans-Peter Kaul in Pre-Trial Chamber II; and
  - b. Judge Mauro Politi in Pre-Trial Chamber III;
- (ii) The Pre-Trial Chambers shall be constituted as follows:


