**THE JUDGES OF PRE-TRIAL CHAMBER III** of the International Criminal Court (the “Court”) are seized with the matter of the election of a Presiding Judge.

1. On 22 April 2008 the Presidency issued the “Decision replacing a judge in Pre-Trial Chamber III” in which it decided that Pre-Trial Chamber III shall be composed of Judge Hans-Peter Kaul, Judge Fatoumata Dembele Diarra and Judge Ekaterina Trendafilova.<sup>1</sup>

2. On 7 May 2008 Pre-Trial Chamber III issued its decision on the “Election of the Presiding Judge of Pre-Trial Chamber III” whereby Judge Fatoumata Dembele Diarra was elected to be the Presiding Judge of Pre-Trial Chamber III.<sup>2</sup>

3. On 24 October 2008 the Presidency issued the “Decision Constituting Pre-Trial Chambers” in which it was decided that Judge Fatoumata Dembele Diarra would be replaced by Judge Hans-Peter Kaul in Pre-Trial Chamber II and Judge Mauro Politi in Pre-Trial Chamber III.<sup>3</sup>

4. The Chamber notes regulation 13(2) of the Regulations of the Court pursuant to which the judges of each Pre-Trial Chamber shall elect a Presiding Judge from amongst their members.

5. The Chamber also notes the meeting of the judges of Pre-Trial Chamber III on 28 October 2008 during which it was decided that Judge Ekaterina Trendafilova will act as the Presiding Judge of the Chamber with immediate effect.


