**1. Pre-Trial Chamber III** (the "Chamber") of the International Criminal Court (the "Court") notes regulation 28 (1) of the Regulations of the Court (the "Regulations") and requests the Prosecutor to clarify his position in respect of the legal characterisation of the armed conflict in the Central African Republic (the "CAR") between 25 October 2002 and 15 March 2003 as referred to in the amended document containing the charges.

2. On 1 October 2008 the Prosecutor filed the "Prosecution's Submission of Public Redacted Version of the Document Containing the Charges against Jean-Pierre Bemba Gombo" to which he appended the "Document containing the charges" as annex A.<sup>1</sup>

3. On 17 October 2008 the Prosecutor filed the "Prosecution's Submission of Amended Document Containing the Charges and Amended List of Evidence" to which he appended the "Amended Document Containing the Charges" (the "DCC") as annex 3A<sup>2</sup>.

4. The Chamber notes regulation 28 of the Regulations, according to which it "may order the participants to clarify or to provide additional details on any document within a time limit specified by the Chamber".

5. The Chamber recalls that, in paragraph 44 of the DCC, the Prosecutor stated that the "war crimes alleged in Counts 2, 4, 5, 6 and 8 of the DCC" took place in the context of a "protracted armed conflict between Bozizé troops

and Pro-Patassé troops", and that it was "immaterial whether the conflict (...) be characterized as international or non-international".<sup>3</sup>

6. Having reviewed the counts referred to in the Prosecutor's submissions, the Chamber observes that, despite the Prosecutor claims that the legal characterisation of the armed conflict is "immaterial", he charges Jean-Pierre Bemba Gombo with war crimes committed within the context of a noninternational armed conflict.<sup>4</sup>

7. The Chamber therefore considers it necessary for the Prosecutor to clarify whether his legal characterisation of the armed conflict in CAR between 25 October 2002 and 15 March 2003 is non-international, international or both.

## FOR THESE REASONS, THE CHAMBER

orders the Prosecutor to clarify his position with respect to the legal characterisation of the armed conflict in Central African Republic between 25 October 2002 and 15 March 2003, in particular in relation to counts 2, 4, 5, 6 and 8 referred to in the Amended Document Containing the Charges no later than 6 November 2008.
