**Judge Ekaterina Trendafilova**, acting as Single Judge for Pre-Trial Chamber III (the “Chamber”) of the International Criminal Court (the “Court”),<sup>1</sup> recalls the Chamber’s Decision on the “Prosecutor’s Application for Warrant of Arrest under Article 58 of the Rome Statute”<sup>2</sup> dated 10 June 2008 and that on the same day the Chamber issued the warrant of arrest<sup>3</sup> against Mr Jean-Pierre Bemba Gombo (“Mr Jean-Pierre Bemba”).

1. On 4 July 2008 the initial appearance of Mr Jean-Pierre Bemba took place and the Chamber decided to set the date for the confirmation of the charges hearing (the “Hearing”) on 4 November 2008.<sup>4</sup> There after, the Hearing was postponed twice<sup>5</sup> and on 29 December 2008 the Single Judge issued the “Decision Setting the Date of the Confirmation Hearing”,<sup>6</sup> in which she decided that the Hearing commences on 12 January 2009.

2. The Single Judge notes articles 61 and 67 of the Rome Statute, rule 122 of the Rules of Procedure and Evidence and regulations 20 and 21 of the Regulations of the Court (the “Regulations”).

3. The Single Judge notes in particular that, pursuant to regulation 21(1) of the Regulations, the “publicity of hearings may extend beyond the courtroom” and therefore, it is appropriate to allow photographs and filming to be taken in the courtroom at the beginning of the Hearing.
