I, Judge Mauro Politi, judge at the International Criminal Court (the "Court");

1. NOTING the "Decision designating a Single Judge on victims' issues", dated 22

November 2006<sup>1</sup>, whereby Pre-Trial Chamber II (the "Chamber") designated

Judge Mauro Politi as Single Judge responsible for all issues arising in connection

with victims' participation in the proceedings in the situation in Uganda (the

"Situation") and in the case of The Prosecutor v. Joseph Kony, Vincent Otti, Okot

Odhiambo and Dominic Ongwen (the "Case");

2. NOTING the Single Judge's "Decision on victims' applications for participation

a/0010/06, a/0064/06 to a/0070/06, a/0081/06 to a/0104/06 and a/0111/06 to

a/0127/06" in the Situation<sup>2</sup> and in the Case<sup>3</sup> dated 10 August 2007 (the "10

August 2007 Decision"), whereby inter alia Applicants a/0090/06, a/0098/06,

a/0112/06, a/0118/06 and a/0122/06 were granted the status of victim of the Case,

Applicant a/0101/06 was granted the status of victim in the context of the

Situation and Applicant a/0119/06 was granted the status of victim both of the

Case and in the context of the Situation;

3. NOTING the Single Judge's "Decision on legal representation of Victims

a/0090/06, a/0098/06, a/0101/06, a/0112/06, a/0118/06, a/0119/06 and a/0122/06" in

the Situation<sup>4</sup> and in the Case<sup>5</sup> dated 15 February 2008<sup>6</sup> (the "15 February 2008

Decision"), whereby Ms Adesola Adeboyejo, Counsel in the Office of Public

Counsel for Victims (the "OPCV" or the "Office"), was appointed as legal

representative of Victims a/0090/06, a/0098/06, a/0112/06, a/0118/06 and a/0122/06,

and Ms Paolina Massidda, Principal Counsel in the OPCV, was appointed as

legal representative of Victims a/0101/06 and a/0119/06;

NOTING the Single Judge's "Decision on victims' applications for participation a/0010/06, a/0064/06 to a/0070/06, a/0081/06, a/0082/06, a/0084/06 to a/0089/06, a/0091/06 to a/0097/06, a/0099/06, a/0100/06, a/0102/06 to a/0104/06, a/0111/06, a/0113/06 to a/0117/06, a/0120/06, a/0121/06 and a/0123/06 to a/0127/06" in the Situation and in the Case, dated 14 March 2008 (the "14 March 2008 Decision"), whereby *inter alia* Applicants a/0094/06, a/0095/06, a/0103/06, a/0121/06 and a/0124/06 were granted the status of victim of the Case, Applicants a/0065/06, a/0068/06, a/0093/06 and a/0096/06 were granted the status of victim in the context of the Situation and Applicants a/0117/06, a/0120/06 and a/0123/06 were granted the status of victim both of the Case and in the context of the Situation;

5. NOTING the Registry's "Report to Pre-Trial Chamber II on applications a/0014/07 to a/0020/07 in accordance with Rule 89 paragraph 1 of the Rules of Procedure and Evidence, and Regulation 86 paragraph 5 of the Regulations of the Court" in the Situation<sup>9</sup> and in the Case<sup>10</sup> dated 11 April 2007, as well as the Registry's "Report to Pre-Trial Chamber II on applications a/0076/07 to a/0125/07 in accordance with Rule 89 paragraph 1 of the Rules of Procedure and Evidence, and Regulation 86 paragraph 5 of the Regulations of the Court" in the Situation<sup>11</sup> dated 22 June 2007 (collectively, the "Registry's Reports");

November 2008<sup>12</sup> (the "17 November 2008 Decision"), whereby Applicants a/0066/06, a/0088/06, a/0091/06, a/0092/06, a/0102/06, a/0115/06, a/0125/06 and a/0126/06 were granted the status of victim in the context of the Situation and Ms Adesola Adeboyejo, Counsel in the OPCV, was appointed as their common legal

representative;

7. NOTING the Single Judge's "Decision on victims' applications for participation a/0014/07 to a/0020/07 and a/0076/07 to a/0125/07" in the Situation<sup>13</sup> and in the Case<sup>14</sup>, dated 21 November 2008 (the "21 November 2008 Decision"), whereby inter alia Applicants a/0076/07, a/0077/07, a/0078/07, a/0081/07, a/0082/07, a/0084/07, a/0085/07, a/0090/07, a/0091/07, a/0092/07, a/0093/07, a/0094/07, a/0095/07, a/0096/07, a/0097/07, a/0098/07, a/0099/07, a/0100/07, a/0101/07, a/0102/07, a/0103/07, a/0105/07, a/0106/07, a/0107/07, a/0112/07 and a/0123/07 were granted the status of victim of the Case, Applicants a/0115/07, a/0117/07 and a/0118/07 were granted the status of victim in the context of the Situation and Applicant a/0108/07 was granted the status of victim both of the Case and in the context of the Situation;

8. NOTING article 68(3) of the Statute of the Court (the "Statute"); rules 90(2) and 90 (4) of the Rules of Procedure and Evidence (the "Rules"); regulation 80 of the Regulations of the Court (the "Regulations");

9. NOTING that, as regards legal representation, the 21 November 2008 Decision held that, in light of the similarity of their respective experiences and with a view to preserving the efficiency of the proceedings, applicants admitted as victims of the Case should be jointly represented by one common legal representative, and applicants admitted as victims in the context of the Situation should also be

jointly represented among themselves and together with victims admitted at an earlier stage of the present proceedings;

- 10. NOTING that, in light *inter alia* of the budget constraints highlighted by the Registrar<sup>15</sup>, the 21 November 2008 Decision held that counsels in the OPCV should be appointed as common legal representatives and, accordingly, requested the OPCV to submit a report assessing the feasibility of the proposed arrangements;
- 11. NOTING the "OPCV Report on legal representation of victims" with Annex confidential *ex parte* OPCV dated 28 November 2008<sup>16</sup>, as well as the Corrigendum thereto dated 1 December 2008<sup>17</sup>, whereby the OPCV suggested the appointment of two counsels from the Office, each of whom would represent a separate group of victims;
- **12. NOTING** that, in the view of the Office, appointment of two counsels would "prevent any conflict of interest from arising among victims', as well as enable "a legal representation taking into account the specificities" of the two categories;
- 13. CONSIDERING that the proposal of the Office appears in line with the approach taken by the 21 November 2008 Decision, which identified two categories of victims, namely victims admitted in the context of the Situation (including those admitted at an earlier stage of the proceedings) and victims of the Case;

- 14. CONSIDERING however that, at this stage of the proceedings, it is appropriate to identify the two groups of victims by the neutral terms established by the 21 November 2008 Decision (ie, "victims of the Case" and "victims in the context of the Situation"), without any reference to the merits of their individual circumstances;
- 15. CONSIDERING that, in particular, the category of "former child soldiers" proposed by the OPCV does not seem to accurately encompass the personal circumstances of all applicants granted the status of victim in the context of the Situation;
- 16. NOTING that the 14 March 2008 Decision requested the Registrar to seek the views of Victims a/0117/06, a/0120/06 and a/0123/06 as regards their legal representation;
- 17. NOTING that the 21 November 2008 Decision requested the Registrar to seek the views of Victim a/0108/07 as regards his legal representation;
- 18. NOTING that such views are yet to be submitted to the Single Judge;
- **19. CONSIDERING** that, accordingly, decision on legal representation of Victims a/0117/06, a/0120/06, a/0123/06 and a/0108/07 is deferred until their views are submitted to the Single Judge;
- **20. NOTING** that the appointments made under the 15 February 2008 Decision were without prejudice to any future determination by the Chamber as regards common legal representation;

**21. NOTING** the detailed information provided by the OPCV as regards the organization of the Office, in particular the turnover of personnel expected in the next few months;

22. CONSIDERING that, accordingly, it appears appropriate to review in part the appointment of legal representatives made under the 15 February 2008 and the 17 November 2008 Decisions, with a view to ensuring continuity in the legal representation of the relevant victims;

# HAVING REGARD THERETO AND FOR THESE REASONS,

**DECIDE** to revoke the appointment of Ms Adesola Adeboyejo as legal representative of Victims a/0066/06, a/0088/06, a/0090/06, a/0091/06, a/0092/06, a/0098/06, a/0102/06, a/0112/06, a/0115/06, a/0118/06, a/0122/06, a/0125/06 and a/0126/06;

**APPOINT** Ms Paolina Massidda, Principal Counsel in the OPCV, as legal representative of Victims a/0065/06, a/0066/06, a/0068/06, a/0088/06, a/0091/06, a/0092/06, a/0093/06, a/0096/06, a/0102/06, a/0115/06, a/0125/06, a/0126/06, a/0115/07, a/0117/07 and a/0118/07, granted the status of victim in the context of the Situation;

**APPOINT** Ms Sarah Pellet, Acting Counsel in the OPCV, as legal representative of Victims a/0090/06, a/0094/06, a/0095/06, a/0098/06, a/0103/06, a/0112/06, a/0118/06, a/0121/06, a/0122/06, a/0124/06, a/0076/07, a/0077/07, a/0078/07, a/0081/07, a/0082/07, a/0084/07, a/0085/07, a/0090/07, a/0091/07, a/0092/07, a/0093/07, a/0094/07, a/0095/07, a/0096/07, a/0097/07, a/0098/07, a/0099/07, a/0100/07, a/0101/07, a/0102/07, a/0103/07, a/0105/07, a/0106/07, a/0107/07, a/0112/07 and a/0123/07, granted the status of victim of the Case;
