HAVING REGARD to regulation 35 of the *Regulations of the Court* (“the Regulations”), Trial Chamber II (“the Chamber”) of the International Criminal Court (“the Court”), hereby makes the following order.

I. BACKGROUND AND SUBMISSIONS

1. On 13 March 2009, the Chamber issued its “Order concerning the Presentation of Incriminating Evidence and the E-Court Protocol”.¹ In it, the Chamber, *inter alia*, ordered the Prosecutor to:

1. Submit a Table of Incriminating Evidence no later than 3 April 2009 at 4 p.m.;
2. Submit a list of all witnesses it intends to call, as well as a Witness Information List for each witness, no later than 3 April 2009 at 4 p.m.;
3. File all items of evidence listed in the Table of Incriminating Evidence, no later than 3 April 2009 at 4 p.m.;
4. Submit a detailed list of all incriminating evidence included in the Table of Incriminating Evidence, providing certain details for each item included, no later than 3 April 2009 at 4 p.m.;
5. Update the metadata for all items of evidence included in the Table of Incriminating Evidence, no later than 24 April 2009 at 4 p.m.;
6. Submit any requests for redactions of the metadata, no later than 9 April 2009 at 4 p.m.;

2. On 19 March 2009, the Prosecution filed an “Urgent Application for Extension of Time Limit Pursuant to Regulation 35 to Submit a Table of Incriminating Evidence and related material in compliance with Trial Chamber II “Order concerning the Presentation of Incriminating Evidence and the E-Court Protocol”², in which the Prosecution asked for an extension of time limit until 3 May 2009. Paragraph 2 of the Application makes reference to items 1, 2, 3 and 6 of the Order, which leaves the Chamber to wonder whether the Prosecution considers that it will have no problems meeting the deadline for items 4 and 5.

3. The Defence for Mr. Mathieu Ngudjolo did not object to a possible extension of the deadline, as long as it would have sufficient time between the submission of the Table and the start of the trial.³ The Defence for Mr. Katanga expressed some reservations about the length of the extension requested, but did not oppose an extension until 15 April 2009. Moreover, the Defence for Mr. Katanga requested the Chamber to insist that the Prosecution provide it with the first two columns of the Table, consisting of the charges and the facts underlying those charges “to reflect the Decision on the Confirmation of Charges”, by 3 April 2009.⁴

II. ANALYSIS

4. The Chamber recalls that it recently decided to set the start date for the trial on 24 September 2009.⁵ In its decision, the Chamber stressed that except for very important reasons, it would not postpone this date. It is therefore of great importance that the parties adhere to the time limits imposed by the Chamber.

5. However, in light of the comments by both Defence Teams, the Chamber accepts the arguments of the Prosecution that it needs more time to complete the Table of Incriminating Evidence.

6. The Chamber notes, however, that the proposed new deadline of 3 May is significantly later than the initial time limit of 3 April originally imposed by the Chamber. Bearing in mind the necessity for the Defence and the Chamber to have a complete overview of the Prosecution case, including the metadata for each item of evidence, the Chamber does not consider it appropriate to also postpone the deadline for the updating of the metadata by an additional month.

7. With regard to the request by the Defence of Mr. Katanga to be provided with the first two columns of the Table at an earlier date, the Chamber deems that, in light of the extended time limit, it would not be opportune to oblige the Prosecution to produce this first instalment. However, if the Prosecution is willing to provide the Defence with an advance (non-binding) copy of the two columns in question as a matter of courtesy, the Chamber would welcome such a gesture.

FOR THESE REASONS,

The Chamber

GRANTS the Prosecution request for an extension of time limit to submit the Table of Incriminating Evidence until 4 May 2009, at 4 p.m.;

GRANTS the Prosecution request for an extension of time limit to file all items of evidence listed in the Table of Incriminating Evidence until 4 May, at 4 p.m.;

GRANTS the Prosecution request for an extension of time limit to submit a detailed list of all incriminating evidence included in the Table of Incriminating Evidence, indicating clearly for each item of evidence when it was disclosed to the Defence and


whether it is still subject to redactions and/or other protective measures until 4 May, at 4 p.m.;

GRANTS the Prosecution request for an extension of time limit to submit a list of all witnesses it intends to call, as well as a Witness Information List for each witness, until 4 May 2009, at 4 p.m.;


ORDERS the Prosecution to submit any requests for redactions of the metadata no later than 27 April 2009, at 4 p.m.;

ORDERS the Prosecution to update the metadata for all the items of evidence included in the Table of Incriminating Evidence, for which no requests for redaction have been made, no later than 4 May 2009, at 4 p.m.;


