I, Judge Cuno Tarfusser, Single Judge responsible for carrying out the functions of Pre-Trial Chamber I in relation to the proceedings of the situation in Darfur, Sudan and any related cases emanating therefrom, including the case of *The Prosecutor v. Bahar Idriss Abu Garda*, at the International Criminal Court<sup>1</sup>;

**NOTING** the "Prosecution's Urgent Request Pursuant to Regulation 37(2) for Extension of Page Limit for the Document Containing the Charges",<sup>2</sup> filed by Prosecutor on 9 September 2009, whereby the Prosecutor requested an extension of page limit for the document containing the charges to be submitted in accordance with article 61(3) of the Statute of the Court;

**NOTING** that in his request the Prosecutor contends that the extension is necessary, due to the complexity of the facts of the case, in order for the facts and their legal characterization to be presented with clarity;

**CONSIDERING** that the presentation of the facts of the case with sufficient clarity and precision as well as their legal characterisation is essential in order to give Mr. Abu Garda sufficient notice of the underlying allegations against him and to assist him in preparing adequately and effectively for the hearing of confirmation of charges;

**NOTING** that pursuant to regulation 37 of the Regulations of the Court "a document filed with the Registry shall not exceed 20 pages", but "the Chamber may, at the request of a participant, extend the page limit in exceptional circumstances";

**CONSIDERING** that the reasons presented by the Prosecutor in his request constitute "exceptional circumstances" within the meaning of regulation 37 of the Regulations of the Court;

**CONSIDERING** that, since the Prosecutor's request relates to evidence that is currently being treated as confidential but that such a need for confidentiality does not exist *vis-à-vis* the Defence, the Prosecutor's request shall be reclassified as "confidential" pursuant to regulation 23*bis*(3) of the Regulations of the Court;
