**PRE-TRIAL CHAMBER I** of the International Criminal Court (the "Chamber" and the "Court" respectively);

**NOTING** the "Urgent Defence Application for an Ex Parte Hearing" dated 22 September 2009, filed as "confidential, with two "confidential ex parte defence" Annexes (the "Defence's Application");<sup>1</sup>
