leave to submit a revised table containing the current level of confidentiality of

the evidence it intends to present at the confirmation hearing, annexed to its

is reclassified from Confidential to Public;4

NOTING regulation 23bis (3) of the Regulations of the Court ("the Regulations");

NOTING the "Prosecution's Notification of compliance with the E-court

Protocol and Application for an Order to CMS to remove 17 Duplicated

documents from the Case Record" of 12 October 2009 ("the Prosecution's

Request");5

NOTING the consultation with the Registry through email on 12 October 2009;

CONSIDERING that, with respect to the Defence's Request, in accordance with

regulation 23bis (3) of the Regulations, "whosoever instigated the reclassification,

be it the Registrar or a participant, shall apply to the Chamber to reclassify the

document", and that therefore the Defence should have applied to the Chamber

for the reclassification of document "DAR-D05-0002-0007" from Confidential to

Public;

CONSIDERING that, with respect to the Prosecution's Request, the Registry

suggested to "keep the duplicates with their existing ERN numbers, not EVD

them, and indicate as a note/metadata that they are indeed duplicates to XXX

- (ii) to indicate as a note/metadata to which item they are duplicate and the EVD number of the correct version;
