NOTING the "Decision on the Prosecutor's request for extension of time-limit",¹ issued by the Single Judge Cuno Tarfusser on 11 September 2009, wherein the commencement of the confirmation hearing was postponed until Monday, 19 October 2009;

NOTING the "Decision on victims' modalities of participation at the Pre-Trial Stage of the Case" issued by the Chamber on 6 October 2009;²

NOTING the "Decision on the 52 Applications for Participation at the Pre-Trial Stage of the Case" issued by the Single Judge Sanji Monageng on 9 October 2009;³

NOTING the "Decision setting a deadline for requests to lift anonymity of victims" issued by the Presiding Judge on 14 October 2009;⁴

NOTING the "1. Request in respect of Lifting of Anonymity of Victims 2. requested the Chamber, *inter alia*, to grant them access to "all documents filed in this case" (the "Legal Representative Request");⁵

NOTING the "Requete aux fins d'etre autorise a acceder aux documents classes confidentiels relatifs aux temoins cites par le Procureur et la Defense pour l'audience de confirmation des charges" submitted on 16 October 2009, whereby the Legal Representative of victims a/0434/09 and a/0435/09 requested access to the statements and confidential documents related to the witnesses intended to be relied upon at the confirmation hearing (the "Legal Representative Request");⁶

NOTING regulations 24, 34 and 35 of the Regulations of the Court;

CONSIDERING that, the opening of the confirmation hearing is scheduled for Monday 19 October 2009 and that in light of the short time-frame, the Chamber deems it appropriate to reduce the time limit granted to the Defence and to the Prosecution to respond to the Legal Representatives' Request;
